4. NATURE OF TRUST :-

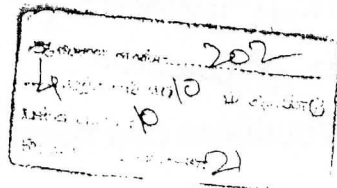

8. **NUCLEUS OF THE TRUST FUND :-**

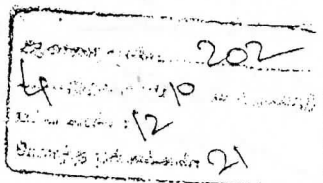
The Trust is established with a nucleus (CORPUS) contribution of Rs. 1400/- (Rupees One Thousand and Four hundred only) by the Founders, receipt of which the Trustees hereby acknowledge. As on today the Trust have no property other than that of Corpus Fund of Rs.1400/- (Rupees One Thousand and Four Hundred only)

9. **MANAGEMENT OF TRUST :-**

This Trust shall be administered by a Board of Trustees whose number shall not be less than **THREE** or more than **TWENTY FIVE**. All the Trustees are Lifetime Trustees. Lifetime Trustees shall have right to nominate one person for his post. They also have right to change their nominees during their life time. The Trust should maintain a record for nominees.

The Trustees shall elect the Chairman, Secretary and Treasurer from among themselves once in **TWO** Years. The routine administration of the Trust, its property and affairs, convening meetings of the Trustees, maintaining minutes, accounts and other documents of the Trust shall be looked after by Chairman and the Secretary of the Board of Trustees.

11. MEETING OF BOARD OF TRUSTEES:

- a) The Board of Trustees shall hold meetings at such intervals as they may decide.
- b) The quorum at each meeting shall be **SEVEN** for the time being.
- c) The Chairman shall be presided all the meetings. If the Chairman is absent or unable to attend the meeting, the secretary of the Trust shall be presided the meetings.

12. DECISIONS BY CIRCULATION:

The Trustees may also take decisions by circulation of Trust matters approved by a majority of Trustees after the matters to be so decided have been circulated to all the Trustees, then in India.

13. POWERS OF BOARD OF TRUSTEES:-

The Board of Trustees shall have and may exercise all such powers, as in their opinion, shall enable them to effectively carry out all or any of the trust Purposes. Without prejudice to the generality of the foregoing, the Board of Trustees shall have the power:

- a) to Purchase, hire, take on lease or invest the corpus of the Trust Fund or any part thereof, in lands and movables properties;
- b) to accept gift in kind or in cash;
- c) to borrow money from any Individual, Firm, Company, Banks and other Financial Institutions on such terms and conditions and (where applicable) subject to payment of interest or otherwise and repay the same as Trustees may consider necessary or desirable;
- d) to sell, mortgage, charge, lease, hire, invest or transpose the Trust investments;
- e) to open bank accounts and generally deal with the Trust Fund or any part thereof as the Trustees may consider necessary or desirable;

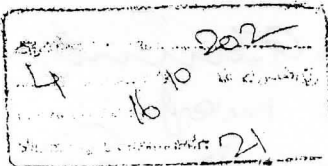

- f) to raise additional funds for augmenting, the corpus of the Trust Fund, if necessary through appropriate programmes, to support the Trust Objects;
- g) to accumulate the income of the Trust of eventual application to the trust Objects pending which to invest the accumulation in accordance with the relevant provisions of the Income Tax Act, 1961.
- h) to employ persons to assist the Trustees in carrying out the trust purposes.

14. RETIREMENT, ETC. OF TRUSTEES:

- a) Any Trustee may retire on giving three months' notice in writing thereof to others.
- b) A Trustee shall automatically cease to be and shall vacate the office of the Trustee on happening of any of the following:

 - ii) if he becomes of unsound mind;
 - iii) if he is adjudged insolvent or if he applies to be so Adjudged;
 - iv) if he is convicted of any offence (Other than an offence not involving moral turpitude) and he is sentenced in respect thereof to imprisonment for not less than six months; and
 - v) if he is absent from India without permission of the Other Trustees (which permission if granted will not be withdrawn) for a continuous period of more than six months.

- c) In case of occurrence of any vacancy of the Trustees by reason of death or resignation of the Trustees or for any other reason, their nominee shall be appointed as Trustees automatically from the date of such vacancy arises.

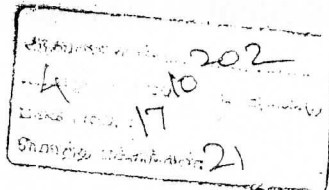
15. **TRUSTEES TO HOLD THE FUND IN TRUST:-**

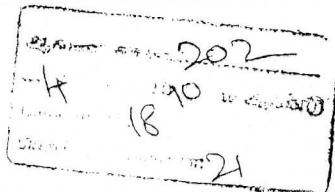
18. INVESTMENTS OF TRUST FUNDS:-

25. AMENDMENTS:

26. DISSOLUTION:

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees but with the prior permission of the Commission of Income Tax the same shall be transferred to another Trust, Society, Association or Institution whose objects are similar to those of this Trust.

27. INDEMNITY:

The Trustees shall be kept indemnified and harmless against any claim, demand or liability arising against them for anything done by them in good faith, pursuant to the power and authority vested in them by these presents.
